Trust Deeds will be returned within thirty (30) working days. Documentation of the release and discharge of the Bail Bond must be presented to the Agent at the address that appears above. Collateral will only be returned to the same person who pledged the collateral. The Agent is not obligated to permit any exchange of collateral. If the Bail Bond is not posted within twenty-four hours of receipt of full payment, or a signed contract for payment, collateral must be returned and lien released within forty-eight hours.
